

In this document you will find screenshots of the entire Visit Japan registration process. We recommend completing these steps in order to “Fast Track” your immigration upon arrival.

In order to complete this process you should have your passport, vaccination details and your travel details close at hand. In the screenshots on the following pages, we have provided the address of the hotel in Tokyo, which you will need during the registration process.

It is important to note that US citizens are not required to obtain a visa to enter Japan. You are allowed a 90 day visa free stay as long as you have a passport that is valid for your entire stay as well as an onward/return ticket for your departure from Japan within that 90 day period. Therefore you may answer “NO” when asked if you have a visa.

Please follow along page by page and we think you’ll whiz through this in no time at all. However, if you get stuck at any point, please contact Mike or Jeff, your trip hosts, and we’ll be happy to help walk you through it.

At the completion you’ll receive two QR codes:

- An Immigration QR Code
- A Customs Declaration QR Code

We suggest taking screenshots of both codes and having them easily accesible on your cell phone, or you may even wish to print the QR codes to present to immigration officials if they ask to see them.

The novel coronavirus (COVID-19) infection will be redefined as a Category V infectious Disease by the Infectious Diseases Control Law on May 8, 2021, and anyone entering Japan on or after that date will no longer be required to show a valid vaccination certificate or a test certificate obtained before departure.

You can complete a part of the quarantine procedure on a website before entering Japan. Via e-mail, you will be notified of review results for documents you submit.

You are encouraged to save an image of the screenshot of the web page from Fast Track, in case you do not have online access when needed. You can save an image of screenshot by using "Save screenshots" icon. Your screenshot is subject to an inspection for authenticity in the quarantine process. Falsifying or misrepresenting the screenshot may result in imprisonment of up to six months or a fine of up to 500,000 yen, pursuant to the provisions of Article 36 of the Quarantine Act.
