In this document you will find screenshots of the entire Visit Japan registration process. We recommend completing these steps in order to "Fast Track" your immigration upon arrival.

In order to complete this process you should have your passport, vaccination details and your travel details close at hand. In the screenshots on the following pages, we have provided the address of the hotel in Tokyo, which you will need during the registration process.

It is important to note that US citizens are not required to obtain a visa to enter Japan. You are allowed a 90 day visa free stay as long as you have a passport that is valid for your entire stay as well as an onward/return ticket for your departure from Japan within that 90 day period. Therefore you may answer "NO" when asked if you have a visa.


